

**LOCAL APPOINTMENT LIST (Per Maddy Act)**  
**GOVERNMENT CODE SECTION 54972**

All members of Commissions, Boards and Committees shall be appointed by the Mayor with the approval of the City Council and shall be bona fide residents of the City (except Utilities Commission members). No member shall be an employee of the city during such membership.

The Mayor may, with the approval of the City Council, appoint one or more alternate members to each board or commission. Alternate members shall have no vote in the proceedings of the board or commission. In the event of a vacancy, subject to confirmation by the City Council, alternate members shall assume the vacated seat for the unexpired portion of the term of the member.

No person shall be at the same time a member of more than one citizen's advisory body created by ordinance or resolution of the City Council, except the Accessibility Appeals Board.

**ARTS COMMISSION** (7 members + 2 teens, 1 alternate) – 3-year terms

**Meets fourth Wednesday of the month at 6 pm, Conference and Recreation Center, 14075 Frederick St., Moreno Valley, CA**

The Commission shall act in an advisory capacity to the City Council to encourage, stimulate, promote, and foster programs for the cultural enrichment of the city and thereby contribute to the quality of life in Moreno Valley and develop an awareness of the value of the arts in Moreno Valley in the business community, in local government, and in the general public. (MVMC Chapter 2.26)

**ACCESSIBILITY APPEALS BOARD** (5 members, currently inactive) – 3-year terms


**Meets on an as-needed basis (approximately within 30 days of an appeal).**
